1. The General Secretariat of the Council has been informed of the resignation of Mr Olivier MEUNIER, as alternate member of the above Committee in the government representatives category (for France).

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Decision 2003/C 218/01 of 22 July 2003¹ on the setting up of an Advisory Committee on Safety and Health at Work, and in particular Article 3 thereof,

Whereas:

- (1) In its Decision of 22 April 2013² the Council appointed the members and alternate members of the Advisory Committee on Safety and Health at Work for the period ending on 28 February 2016.
- (2) A seat as alternate member in the government representatives category has fallen vacant as a result of the resignation of Mr Olivier MEUNIER.
- (3) The government of France has nominated a candidate for the vacant seat,
