Subject: Advisory Committee on Safety and Health at Work

1. The General Secretariat of the Council has been informed of the resignation of Mr Miroslav KOSINA, as alternate member of the above Committee in the employees' representatives category (for Czech Republic).
2. Under Article 3 of Decision 2003/C 218/01, members and alternate members are appointed by the Council.

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Decision 2003/C 218/01 of 22 July 2003¹ on the setting up of an Advisory Committee on Safety and Health at Work, and in particular Article 3 thereof,

Whereas:

- (1) In its Decision of 22 April 2013² the Council appointed the members and alternate members of the Advisory Committee on Safety and Health at Work for the period ending on 28 February 2016.
- (2) A seat as alternate member in the employees' representatives category has fallen vacant as a result of the resignation of Mr Miroslav KOSINA.
- (3) The government of Czech Republic has nominated a candidate for the vacant seat,
