The SCA confirmed that it had no intention to object to the delegated act and it assumed that the Council does not intend to object to it.

- Presidency compromise text

15460/14 AGRILEG 221 CODEC 2233

Delegations expressed their views on the compromise text. Most delegations were of the view that the text is a step in the right direction and that they can generally support the new amendments providing more flexibility for mixed farms and for the derogations to the rules on production of plant, livestock, seaweed and aquaculture animals.

On the scope, opinions diverged: many delegations took the view that Annex I should constitute an essential element that can be only modified by the ordinary legislative procedure; several delegations supported the possibility to supplement Annex I by delegated acts and some others would prefer to stick to the current legislation (categories). Many delegations found it necessary to discuss the dossier at the technical level.

The Commission representative supported the efforts of the Presidency, took the view that the new compromise text was heading in the right direction and indicated that its Institution would support moving rapidly forward on this dossier. The SCA took note of the amendments presented by the Presidency. The Presidency will continue its work and will submit a new compromise text to the next SCA. The Presidency recognised the need to examine some technical details at the Working Party level.

5. Strengthening of EU policies for young farmers

The SCA had an exchange of views on the content of the Presidency paper on strengthening of EU policies for young farmers set out in docs. 15127/14 + COR 1.
