Ministerial Order of
on an appointment (judiciary)

The Keeper of the Seals, Minister for Justice,

Having regard to Order No 58-1270 of 22 December 1958, as amended, establishing an organic law on the status of the judiciary, and in particular Articles 67 and 68 thereof;

Having regard to Law No 84-16 of 11 January 1984, as amended, laying down statutory rules on the State public service, and in particular Articles 41 to 44 thereof;

Having regard to Decree No 67-290 of 28 March 1967, as amended, setting out the rules for calculating the remuneration of employees of the State and of State public institutions of an administrative nature serving abroad;

Having regard to Decree No 85-986 of 16 September 1985, as amended, on the special arrangement for certain civil service posts, secondment, entry into service and termination of service, and in particular Articles 1 to 12 thereof;

Having regard to the Ministerial Order of 22 December 2006 applying Decree No 67-290 of 28 March 1967, as amended, setting out the rules for calculating the remuneration of employees of the State and of State public institutions of an administrative nature serving abroad to Ministry of Justice officials posted abroad, and in particular Article 4 thereof;

Having regard to the Decision of the Council of the European Union of 28 February 2002, as amended, setting up Eurojust with a view to reinforcing the fight against serious crime, and in particular Articles 2 and 33 thereof;

Having regard to the application submitted by the person concerned;

Hereby orders as follows:

Article 1

Mr Frédéric Baab, Deputy General Inspector of Judicial Services, shall be appointed National Member for France of the judicial cooperation unit Eurojust in The Hague (Netherlands) for four years from 20 October 2014. Mr Baab shall be placed in salary group 4, within the meaning of Article 4 of the Ministerial Order of 22 December 2006 applying Decree No 67-290 of 28 March 1967, as amended, setting out the rules for calculating the remuneration of employees of the State and of State public institutions of an administrative nature serving abroad to Ministry of Justice officials posted abroad.

Article 2

The Director of Judicial Services shall be responsible for the implementation of this Order.
