Subject:	Proposal for transfer of appropriations No 2/2014 within Section X - European External Action Service - of the general budget for 2014

1. On 2 December 2014, the European External Action Service (EEAS) submitted to the Council proposal for transfer of appropriations No 2/2014.

The purpose of this proposal is to transfer non-differentiated appropriations for a total amount of EUR 2.47 million, of wich:

- a) EUR 1.86 million from several budget lines in Title 1 (*Staff at headquarters*) and EUR 0.29 million from budget lines in Title 2 (*Buildings and associated costs*) to Items 3 0 0 2 (*Other expenditure related to staff*) and 3 0 0 3 (*Buildings and associated costs*); and
- b) EUR 0.32 million from several budget lines in Title 2 (*Buildings and associated costs*) to Article 2 1 2 (*Technical equipment*) and Item 2 2 1 0 (*Documentation and library expenditure*).

- 2. The transfer is being proposed to:
 - a) cover entitlements to installation allowances and removal costs for staff who moved between delegations and between delegations and headquarters, and to purchase a building suitable for diplomatic activities for the EEAS delegation in Albania;
 - b) acquire new, up-to-date X-ray scanners to better protect the entrances of EEAS buildings in Brussel and to upgrade EEAS subscription to *Jane's* services.
- 3. The <u>Budget Committee</u> examined the proposal for a transfer at its meeting on 5 December 2014.
- 4. Following that examination, the <u>Budget Committee</u> agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
 - the proposed transfer of appropriations;
 - the draft letter in the ANNEX to that effect.
