We registered your request of 23 October 2013 for access to the following documents on 24 October 2013: 14543/13, 14679/13, 14679/1/13 REV 1, 14679/13 ADD 1, 14681/13, 14681/1/13 REV 1 and 14681/13 ADD1.

Thank you for your interest.

The General Secretariat of the Council has examined your request on the basis of Regulation (EC) No 1049/2001 of the European Parliament and of the Council regarding public access to European Parliament, Council and Commission documents<sup>1</sup> (hereafter the "Regulation") and specific provisions of the Council's Rules of Procedure<sup>2</sup> and has come to the following conclusion:

You may have access to the following documents: 14679/13, 14679/1/13 REV 1, 14679/13 ADD 1, 14681/13, 14681/1/13 REV 1 and 14681/13 ADD1. You may also have access to the last version of 14681/13 set out in document 14681/2/13 REV 2.

Document **14543/13** is the outcome of proceedings from the Eastern Europe and Central Asia Working Party (COEST) to the Political Security Committee (PSC) on the COEST meeting of 7 October 2013.

Annex II to the Council's Rules of Procedure – Council Decision No 2009/937/EU; Official Journal L 325, 11.12.2009, p. 35.

This document relates to the discussions held at COEST meetings related to the annual review of the restrictive measures against Belarus. The information it contains refers to aspects of the discussions on the compromise texts and concerning listing/de-listing procedures for restrictive measures against persons or entities. Disclosure of this information could not only hamper internal discussions on these difficult issues but also weaken the European Union's position in terms of international relations.

Accordingly, pursuant to Article 4(1)(a), third indent of the Regulation (protection of the public interest as regards international relations) and in the absence of any evidence of an overriding public interest in release also pursuant to the second subparagraph of Article 4(3) of the Regulation (protection of the decision-making process of the Council), the General Secretariat is unable to grant you full access to this document.

However, pursuant to Article 4(6) of the Regulation, you may have access to those parts of the document which are not covered by these exceptions.

#### Statutory remedy notice

Pursuant to Article 7(2) of the Regulation, you may submit a confirmatory application requesting the Council to reconsider this position, within 15 working days of receiving this reply<sup>1</sup>.

I refer to your letter of 14 November 2013 attached. I hereby lodge a confirmatory request for full access to document 14543/13.

In the first place, I observe that your letter contains mere assertions that disclosure would undermine the decision making and weaken the EU's position in terms of international relations, but nor reasoning or evidence that would support these assertions.

Secondly, your assertions are unconvincing. The EU is imposing the sanction against Belarus in order to promote the respect for human rights in that country. In order for this to be credible, it is important that the decision-making process is transparent, in particular in relation to the decisions for listing or de-listing certain persons. Making this decision making process transparent would not weaken but strengthen the EU position in international relations because it would add credibility to the EU's approach (which credibility, as you know, is seriously undermined by the many mistakes made by the institutions and the resulting judgments by the EU courts annulling the listing of designated persons). The disclosure would also in no way undermine the EU's internal decision making process.
