#### **ITEMS DEBATED**

#### Meeting of the Conciliation Committee with the European Parliament

The Council and the European Parliament agreed that further efforts were needed to find an overall compromise on the 2015 EU budget and some amendments to the 2014 budget that would be satisfactory for all sides. Talks were therefore suspended to allow the Italian presidency to continue its work to that end. The Conciliation Committee will resume at 16.00 on 17 November. The three-week conciliation period expires at 24.00 the same day. If no agreement has been reached by then, the Commission will have to submit a new draft budget.

The Conciliation Committee is made up of the 28 members of the Council and an equal number of Members of the European Parliament.
