Following agreement in COREPER on 5 September 2014 to use the written procedure for the adoption of the Council Decision and Council Regulation concerning restrictive measures in view of Russia's actions destabilising the situation in Ukraine, as well as of the Council Decision, Council Regulation and Council Implementing Regulation concerning restrictive measures in respect of actions undermining or threatening the territorial integrity, sovereignty and independence of Ukraine, the Presidency now proposes the adoption of those texts.
