	- Roadmap for 2015

Delegations will find below the above-mentioned roadmap as presented by the incoming Presidency.

Following established practice, the incoming Presidency has prepared this roadmap which covers both the 2015 European semester and the mid-term review of the Europe 2020 strategy given the close links between the two exercises. As regards the European semester, the roadmap outlines all key steps of the 2015 semester and provides preliminary indications on the focus of discussions in certain fora. Concerning the Europe 2020 strategy, the roadmap builds on the work undertaken by the Council during the Italian Presidency (doc. 16025/14) and provides indications for 2015.

The objectives of the roadmap are to ensure that all relevant Council formations, and their preparatory bodies, work in a coordinated and consistent manner towards a thorough preparation of the European Council debates on the European semester and the Europe 2020 strategy and to enable the General Affairs Council and COREPER to oversee the process.

The roadmap is divided in two phases: the first, with more details, until the March European Council, and the second, more indicative, for the period between the European Council meetings in March and June 2015. After the March EC, an updated roadmap will be presented, as appropriate.

The intention of the incoming Presidency is to discuss the Annual Growth Survey in the meetings of the ECOFIN, EPSCO, Competitiveness, Energy and Environment Council formations in February - March 2015 as part of a broader debate on the policies concerned. These debates will address issues such as governance, implementation and investments and pay special attention to digital aspects. The proposed involvement of the Council after the March European Council reflects broader policy discussions and deliverables in the context of the Europe 2020 strategy and its main objectives.

The incoming Presidency is initiating discussions with the chairs of the Committees (EFC, EPC, EMCO, SPC) with a view to coordinating the management of their work throughout the semester and in the final stages of the mid-term review. The incoming Presidency will keep COREPER informed.

The Presidency and the incoming Presidency welcome the European Parliament's efforts, reflected in its resolution of 22 October 2014 on the European semester, to enhance parliamentary involvement in the European Semester.
