Subject:	Proposal for a Decision of the European Parliament and of the Council on the mobilisation of the EU Solidarity Fund

1. On 8 September 2014, the <u>Commission</u> forwarded to the Council a proposal for a Decision of the European Parliament and of the Council on the mobilisation of the EU Solidarity Fund for a total amount of EUR 46.99 million in commitment and payment appropriations.

The objective of this proposal is to provide financial assistance to Croatia, Greece, Italy and Slovenia in response to natural disasters that occurred between November 2013 and February 2014.

- 2. At the trilogue on 8 December 2014, the European Parliament and the Council reached an *ad referendum* agreement on the mobilisation of the EU Solidarity Fund in the context of the draft package comprising the new draft budget for 2015, the outstanding draft amending budgets relating to 2014 and draft statements.
- 3. On 9 December 2014, the <u>Permanent Representative Committee</u> reached a political agreement on the above mentioned package.
- 4. Therefore, the <u>Permanent Representative Committee</u> is invited to advise the Council to confirm the agreement reached on the mobilisation of the EU Solidarity Fund and to consequently adopt the text of the Decision as set out in the Annex.

DECISION OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL

on the mobilisation of the European Union Solidarity Fund

THE EUROPEAN PARLIAMENT AND THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EC) No 2012/2002 of 11 November 2002 establishing the European Union Solidarity Fund¹, and in particular Article 4(3) thereof,

Having regard to the Interinstitutional Agreement of 2 December 2013 between the European Parliament, the Council and the Commission on budgetary discipline, on cooperation in budgetary matters and on sound financial management², and in particular point 11 thereof,

Having regard to the proposal from the European Commission,

Whereas:

- The European Union has created a European Union Solidarity Fund (the "Fund") to show (1) solidarity with the population of regions struck by disasters.
- Article 10 of Council Regulation (EU, Euratom) No 1311/2013³ allows the mobilisation of (2) the Fund within the annual ceiling of EUR 500 million (2011 prices).
- Regulation (EC) No 2012/2002 contains the provisions whereby the Fund may be mobilised. (3)

- (4) Italy has submitted an application to mobilise the Fund, concerning floods.
- (5) Greece has submitted an application to mobilise the Fund, concerning an earthquake.
- (6) Slovenia has submitted an application to mobilise the Fund, concerning ice storms.
- (7) Croatia has submitted an application to mobilise the Fund, concerning ice storms followed by flooding.

HAVE ADOPTED THIS DECISION:

Article 1

For the general budget of the European Union for the financial year 2014, the European Union Solidarity Fund shall be mobilised to provide the sum of EUR 46 998 528 in commitment appropriations.

For the general budget of the European Union for the financial year 2015, the European Union Solidarity Fund shall be mobilised to provide the sum of EUR 46 998 528 in payment appropriations.

Article 2

This Decision shall be published in the Official Journal of the European Union.
