"We oppose European Commission's Delegated Act, adopted on the 28th August, on a first set of GSP+ candidatures.

We argue the procedure adopted by the European Commission that has chosen to present its decision on the ten applications to GSP+ in a single Delegated Act. This "package" decision is a possibility admitted by the GSP Regulation under article 290 of TFEU, but it is not a legal imposition.

It would have been possible for the Commission to adopt a single Act for each candidature. A Delegated Act on each candidature would allow an individual analysis of each candidature on the basis of its own merits.

We sustain that European Commission's option has systemic implications, distorting the legislative process, at it diminishes the control role of the other Institutions: Council and European Parliament. And it may represent a precedent for the future, which we want to prevent."

"Spain endorses the establishment of a European Border Surveillance System (EUROSUR) for the exchange of information and cooperation between the Member States and FRONTEX for the purpose of detecting, preventing and combating illegal immigration and cross-border crime, contributing to ensuring the protection, and saving the lives, of migrants.

Since 2008, Spain has been working on the pilot project designed to improve situational awareness and increase reaction capability at its external borders.

Nevertheless, Spain cannot vote in favour of the text of the Regulation of the European Parliament and of the Council establishing the European Border Surveillance System (PE-CONS 56/13) since, as that Regulation constitutes a development of Schengen, its Article 19 and recital 16 concerning the participation of Ireland and the United Kingdom contravene Protocol No 19 on the Schengen acquis integrated into the framework of the European Union."

While awaiting the final position of the European Parliament on the possibility to engage in negotiations the Committee held an in-depth discussion on the basis of document 14360/13 in order to provide guidance for the future work of the Council on four issues:

- threshold for biofuels produced from crops: while a range of views from 5% to at least 7% was expressed the Chair concluded that the principle of such a threshold should be retained and that 7% was a figure close to the final one, noting that the EP supported 6%;
- a sub-target for advanced biofuels: again a broad range of views from no sub-target at all to one set at 2.5%, which led the Chair to conclude that at least there was broad agreement on the need to stimulate advanced biofuels, noting the link between this sub-target and that for conventional biofuels. The preference for a closed Annex IX, which it should be possible to amend was also noted;
- electricity from renewable sources in transport: there was broad agreement that incentives (multiple counting) should be higher for road than for rail;
- ILUC factors: a number of delegations are not yet convinced of the availability of enough scientific evidence to support the use of these factors in selecting biofuels. The Chair suggested that combining their use for reporting purpose with some review mechanism might be a way forward.

The emerging convergence on the above elements will allow to use them as a basis for the future work of the WP on ILUC.

- This was followed by breakfast where the discussion focussed on the Eurogroup debrief and economic situation.
- The Council was preceded by an informal session on three topics. First Ministers had an exchange of views on the basis of an EFC note on backstop arrangements in the context of banks' asset quality reviews and stress tests. Ministers agreed that the communication strategy needs to be prepared well in advance. The EFC was asked to work on the key issues raised with a view to a discussion in ECOFIN in November.
- Next, Ministers explored the various questions and options for setting-up support mechanisms for resolution funds and non-euro area SSM/SRM participants. The EFC was mandated to further work on the issue and report back in November.

- Ministers also had an exchange of views on the approach foreseen by the Commission regarding the investment clause in the preventive arm of the Pact. The Presidency will report in a letter to the PEC that the ECOFIN was divided on the topic.
- During the formal Council meeting, the Single Supervisory Mechanism was adopted as an A item.
- Ministers were then updated on the progress on key legislative files.
- This was followed by an exchange of views on indicators for economic policy co-ordination and on the Commission-EIB SME initiative. The Presidency will summarise both discussions in a letter to the President of the European Council ahead of the October European Council.
- Afterwards there was an exchange of views on the lessons learnt from the 2013 European semester exercise and possible improvements for 2014. The Presidency will take into account the discussion when preparing the synthesis report for the General Affairs Council.
- The Council was then debriefed on the main outcomes of the G20 Ministerial and IMF meetings in Washington on 10-13 October. The Commission and Presidency will shortly send Ministers their joint debriefing letter on the G20 outcomes.
- Finally, the Council confirmed the agreement recently reached by the Committee on the draft Council conclusions regarding climate finance.

52. Proposal for a Directive of the European Parliament and of the Council on the freezing and confiscation of proceeds of crime in the European Union (First reading)

- Request for guidance on Articles 5 and 10

The Committee discussed questions on Articles 5 and 10 of the draft Directive on the basis of document 14603/13, with a view to providing guidance in the context of the negotiations with the European Parliament.

As regards Article 5, the Council Legal Service made it very clear that the inclusion of 'death', as a situation in which non-conviction based confiscation could be ordered, would be illegal. Various Member States equally expressed their opposition to such inclusion.

A very large majority of Member States stated that they could not agree to the large possibility for non-conviction based confiscation as set out in Article 5(2) as proposed by the European Parliament. The Chair invited the Working Party to look for alternative solutions on this point.

On Article 10, three Member States expressed misgivings on the proposal for a compromise text on Article 10(3), but a large majority of Member States indicated that they could accept such new text, on condition that the European Parliament shows flexibility on other points.

The Chair invited the Working Party to continue its work on this file on that basis with a view to reaching an agreement with the European Parliament in the near future.

53. Enlargement Package 2013
- Presentation by the Commission

The Committee took note of the presentation by the Commission of its 2013 Enlargement Communication and Progress Reports. The Presidency indicated that these documents would be discussed in the competent Council bodies (Enlargement and COWEB Working Parties) in the course of October and November. The Committee will return to discuss a draft of Council conclusions from 27 November 2013 onwards in view of the General Affairs Council on 17 December 2013.

60. Preparation of the Council meeting (Foreign Affairs) on 21 October 2013
- Eastern Partnership

The Committee prepared the 21 October 2013 FAC discussions on the preparations for the Vilnius Eastern Partnership Summit.

- Southern Neighbourhood

The Committee did not discuss this sub-item.

- Myanmar/Burma

The EEAS representative indicated that in preparation of the ministerial lunch with Nobel Peace Prize laureate Daw Aung San Suu Kyi and based on the Comprehensive Framework for the European Union's policy and support to Myanmar/Burma, adopted by the Council in July 2013, the Council will have an exchange of views on the evolution of the reform process in Myanmar/Burma and the challenges in the run-up to the 2015 elections.

- **Draft Council conclusions on Syria**

The Committee discussed draft Council conclusions on Syria, as set out in document 15053/13, and forwarded them for discussion and possible adoption to the Foreign Affairs Council (FAC).

The Committee:

- took note of the PL statement on the delegated acts regarding the IT systems of the Member States to be issued pursuant to art. 114 (8) and art. 114 (9) of the Common Provisions Regulation (CPR);
- invited the Presidency to inform the EP accordingly.

"Statement by Poland

on the delegated acts regarding the IT systems of the Member States to be issued pursuant to art. 114 (8) and art. 114 (9) of the Common Provisions Regulation (CPR)

Poland understands that the change in the classification of the acts referred to in article 114(8) (concerning the scope of data on each operation to be collected and stored in the IT systems established by the Member States) and article 114(9) (concerning the minimum scope of data and documents required within the audit trail) from implementing acts into delegated acts shall not constitute a basis for the European Commission to increase the scale of the administrative burden on beneficiaries due to the obligations concerning the scope of the data required to be collected and stored in the information systems of the Member States.

Such an effect would in fact be contrary to the aim that has been set for the Commission and the Member States within the roles carried out by them in relation to the ESI Funds, formulated in article 4(10), which is to reduce the administrative burden for beneficiaries, as well as the very concept of the e-Cohesion (article 112(3)). It should be noted that the scope of data and documents covered by the abovementioned delegated acts will determine the scope of data and documents that will be required from the beneficiaries. The mere computerisation of the process of communication between the beneficiary and the institutions that is required to be ensured by the Member State in accordance with article 112(3) cannot be treated as the fulfillment of the objective to reduce the administrative burden for beneficiaries, if at the same time the bureaucratic requirements put on beneficiaries will be increased, e.g. by increasing the scope of data and documents required in the process of the implementation of projects co-financed from EU funds."

- committed to continue the negotiations with the European Parliament along the lines set out in the Presidency Non-paper, while taking account of the concerns certain delegations raised.
