Dear Mr Corsepius

In accordance with the Article 36(2) of Council Decision 2008/615/JHA of 23 June 2008 on the stepping up of cross-border cooperation, particularly in combating terrorism and cross border crime, the Estonian Republic declares that it has implemented the obligations imposed on it under the Decision.

The Estonian Republic also declares that it will apply immediately the Council Decision 2008/615/JHA of 23 June 2008 in its relations with all other Member States which have given the same notification.

For the purpose of Article 19 of Council Decision 2008/616/JHA, the independent data protection authority is the Estonian Data Protection Inspectorate (Andmekaitse Inspektsioon).
