Subject: COMMISSION DELEGATED REGULATION (EU) No .../. of 30.1.2015 amending Delegated Regulation (EU) No 241/2014 supplementing Regulation (EU) No 575/2013 of the European Parliament and of the Council with regard to regulatory technical standards for Own Funds requirements for institutions
= intention not to raise objections to a delegated act

1. The Commission submitted the above delegated act to the Council in accordance with the procedure set out in Article 290 TFEU and with Article 28(5) of Regulation (EU) No 575/2013¹.
2. The Commission having notified the delegated act as regards on 30 January 2015, the Council may object within 1 month.
3. Only Belgium raised an objection during the silence procedure expired on 10 February 2015.

4. It is therefore suggested that Coreper recommend that the Council confirm that it has no intention to object to the delegated act and that the Commission and the European Parliament are to be informed thereof. This implies that, unless the European Parliament objects to it, the delegated act shall be published and enter into force in accordance with Article 28(5) of Regulation (EU) 575/2013.
