Subject:	Proposal for transfer of appropriations No 3/2013 within Section IX - European Data Protection Supervisor - of the general budget for 2013

1. On 28 November 2013, the <u>European Data Protection Supervisor</u> submitted to the Council proposal for transfer of appropriations No 3/2013.

The purpose of this proposal is to transfer a total amount of EUR 320 000 from Items 1000 (*Remuneration and allowances*), 1100 (*Remuneration and allowances*) and 1110 (*Contract Staff*) to Item 2000 (*Rents, charges and building expenditure*).

2. The European Data Protection Supervisor proposes to transfer surpluses in its budget for 2013 to the lines covering expenditure related to its buildings in Brussels.

- 3. The <u>Budget Committee</u> examined the proposal for a transfer at its meeting on 5 December 2013. Several delegations having raised objections on the budgetary operation proposed and, by virtue of the second sentence of Article 25(2) of the Financial Regulation of 25 October 2012<sup>1</sup>, transfer No 3/2013 was subject to the procedure of Article 27 thereof.
- 4. Following that examination, the Budget Committee agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to:
  - refuse the proposed transfer of appropriations;
  - approve the draft letter in the ANNEX to that effect.
