1. The General Secretariat of the Council has been informed of the resignation of Ms Ivana GUBEROVIĆ as member of the above Committee in the government representatives category (for Croatia).

Having regard to Council Regulation (EEC) No 1612/68 of 15 October 1968 on freedom of movement for workers within the Community<sup>1</sup>, and in particular Articles 26 and 27 thereof,

Whereas:

- (1) In its Decision of 25 September 2014<sup>2</sup>, the Council appointed the members and alternate members of the Advisory Committee on Freedom of Movement for Workers for the period ending on 24 September 2016.
- (2) A seat as member in the government representatives category has fallen vacant as a result of the resignation of Ms Ivana GUBEROVIĆ.
- (3) The Government of Croatia has submitted a nomination for the vacant seat,
