INTRODUCTION

- 1. We are the legal representatives of DELETED ("our client"), instructed to apply pursuant to Article 263 TFEU for the annulment of the above-mentioned Decision and Regulation.

BACKGROUND

3. We set out below requests for information and/or documents under Regulation (EC) No 1049/2001 of the European Parliament and of the Council of 30 May 2001 regarding public access to European Parliament, Council and Commission documents ("Regulation 1049/2001") and requests in relation to data protection under Regulation (EC) No 45/2001 of the European Parliament and of the Council of 18 December 2000 on the protection of individuals with regard to the processing of personal data by the Community institutions and bodies and on the free movement of such data ("Regulation 45/2001").

DISCLOSURE REQUIRED UNDER REGULATION 1049/2001

- 4. Pursuant to the right of access to documents in Regulation 1049/2001, we hereby request the following documents and/or information arising out of the reasons given in the Decision and Regulation for adding our client to the list in Annex II to Regulation (EU) No 36/2012:
 - a. All documents and/or information which relate to our client.
 - b. All documents and/or information describing precisely the alleged "covert shipments of oil to the Syrian regime" which our client is alleged to have organised. Please specify precisely:
 - i. the particular shipments concerned;
 - ii. the "oil" products alleged to have been shipped;
 - iii. the particular shipments concerned;
 - iv. what was meant by the use of the term "covert";
 - v. how the alleged shipments were alleged to have been "covert";
 vi. what was meant by "the Syrian regime"; and

 - vii. which element or elements of the so-called "Syrian regime" were alleged to have been the recipients of the shipments.
 - c. All documents and/or information describing precisely how the alleged shipments provided "support to the Syrian regime".
 - d. All documents and/or information describing precisely how the alleged shipments led to our client "benefitting from that regime".
 - e. All documents and/or information describing precisely how the alleged shipments led to our client "benefitting from that regime".
 - In each case please specify the source of the information and/or documentation and the date upon which it was received by the Council.
 - g. All documents and/or information relied on by the Council in assessing the accuracy of the documents and information referred to above.
 - h. All documents and/or information relied on by the Council in determining the nature and extent of the restrictions to be placed on our client, in particular in relation to any consideration of the proportionality of the restrictions.

REQUESTS UNDER REGULATION 45/2001

- 5. As regards our client's rights under Regulation 45/2001, we make the following requests:
 - a. Pursuant to Article 12 of Regulation 45/2001, please confirm that data has been supplied to the Council relating to the applicant ("the data subject") from a person or persons other than the data subject.
 - b. Pursuant to Article 12 of Regulation 45/2001, please provide the data subject with the following information:
 - i. the identity of the controller;
 - ii. the purposes of the processing operation;
 - iii. the categories of data concerned:
 - iv. the recipients or categories of recipients;
 - v. the existence of the right of access to, and the right to rectify, the data concerning the data subject;
 - vi. the legal basis of the processing operation for which the data are intended:
 - vii. the time-limits for storing the data;

- viii. the origin of the data and whether the controller contends that it cannot disclose this information for reasons of professional secrecy; and
- ix. such further information is necessary, having regard to the specific circumstances in which the data are processed, to guarantee fair processing in respect of data subject.
- Our client, the applicant/data subject requests the following under Article 13 of Regulation 45/2001:
 - i. confirmation as to whether or not data related to it are being processed;
 - ii. Information at least as to the purposes of the processing operation, the categories of data concerned, and the recipients or categories of recipients to whom the data are disclosed;
 - iii. communication in an intelligible form of the data undergoing processing and of any available information as to their source; and
 - iv. the logic involved in any automated decision process concerning data relating to the data subject.
- d. For the avoidance of doubt, the applicants/data subject wishes to have rectified under Article 14 of Regulation 45/2001 without delay inaccurate and incomplete personal data which it believes is held by the Council.
- e. The applicant/data subject requests under Article 15(1) of Regulation 45/2001 that the data held by the Council relating to it be blocked because their accuracy is contested by the data subject.

E. STRICT TIME LIMITS FOR URGENT ACTION

6. In view of the strict time limits imposed by Article 263 TFEU within which applications for annulment must be lodged at the General Court, we request that the documents/disclosure requested under Regulation 1049/2001 be sent to DELETED in machine-readable electronic format to the specific email addresses of:

The General Secretariat of the Council has examined your request on the basis of the applicable rules: Regulation (EC) No 1049/2001 of the European Parliament and of the Council regarding public access to European Parliament, Council and Commission documents (OJ L 145, 31.5.2001, p. 43) and the specific provisions concerning public access to Council documents set out in Annex II to the Council's Rules of Procedure (Council Decision No 2009/937/EU, OJ L 325, 11.12.2009, p. 35).

You may have access to documents under reference numbers 1-13 and 22-24.

In addition, you may have access to the partially accessible version of documents under reference numbers 14-20.² However, I regret to inform you that full access to these documents cannot be granted for the reasons set out below. Furthermore, access cannot be granted to document under reference number 21 for the reasons set out below.

The documents under reference numbers 14-19 are all meeting room documents pertaining to the adoption of the Union's legislation imposing restrictive measures in view of the situation in Syria. The Council has checked each of these documents individually but found that public release of any of them would enable third countries to assess the differences between the proposals for sanctions and the final outcome. This would enable third countries to determine to what extent the Union is prepared to go with its restrictive measures policy. Revealing that information would be detrimental to the Union's ability to use restrictive measure to their maximum effect. For this reason, public access is refused under Article 4(1)(a), third indent (protection of the public interest as regards international relations) of Regulation 1049/2001.

Pursuant to Article 4(6) of the Regulation, the General Secretariat has assessed for each document whether any part of it would not fall within this exception and determined that this is the case for certain parts of the documents which may thus be released.

The document under reference number 20 is a "I/A" Item Note from the General Secretariat to the Permanent Representatives Committee and the Council relating to the adoption of the Council Implementing Decision implementing Decision 2013/255/CFSP concerning restrictive measures against Syria and the Council Implementing Regulation implementing Regulation (EU) No 36/2012 concerning restrictive measures in view of the situation in Syria.

Annex I to the document sets out draft responses to observations received from the lawyers of two persons whose statements of reasons the Council intends to amend. These draft responses contain both personal data of the persons whom the responses are addressed to and content which enables the identification of these persons. Disclosure of this information would undermine the protection of privacy and the integrity of the individuals in question, in particular in accordance with Community legislation regarding the protection of personal data. Accordingly, pursuant to Article 4(1)(b) of the Regulation (protection of privacy and the integrity of the individual), the General Secretariat is unable to grant you access to Annex I to the document.

Furthermore, certain parts of Annex 1 contain information which relate to one on-going case and one closed case before the EU Courts concerning restrictive measures against Syria. Disclosure of those parts of the Annex would undermine the protection of the on-going court proceedings as well as future court proceedings on similar issues. Accordingly, also pursuant to Article 4(2), second indent, of Regulation (protection of court proceedings and legal advice), the General Secretariat is unable to grant you access to Annex I to the document.

Pursuant to Article 4(6) of the Regulation, the General Secretariat has assessed whether any part of this document would not fall within this exception. It has determined that this is the case for certain parts of the document which may thus be released.

The document under reference number 21 is a COREU with the number 231/14. This document is classified EU RESTRICTED, meaning that the release of the information contained in it could be disadvantageous to the interests of the European Union or of one or more of the Member States.³ It contains information relating to the activities of entities and individuals providing support to the Al Assad regime in Syria. Public disclosure of this document would allow the public, and hence the Syrian regime, to know what intelligence the EU possesses in relation to this issue. Public disclosure of this information would therefore be detrimental to the Union's efforts to ensure the effectiveness of the restrictive measures imposed on Syria. For this reason, public access is refused under Article 4(1)(a), third indent (protection of the public interest as regards international relations) of Regulation 1049/2001
