#### DECISION No 2/2014 OF THE EU-SWISS JOINT COMMITTEE established under Article 14 of the Agreement of 21 June 1999 between the European Community and its Member States, of the one part, and the Swiss Confederation, of the other, on the free movement of persons, amending Annex III of the Agreement on mutual recognition of professional qualifications

#### THE JOINT COMMITTEE,

Having regard to the Agreement between the European Community and its Member States, of the one part, and the Swiss Confederation, of the other, on the free movement of persons ('the Agreement') and in particular Articles 14 and 18 thereof,

Whereas:

- (1) The Agreement was signed on 21 June 1999 and entered into force on 1 June 2002.
- (2) Annex III (Mutual recognition of professional qualifications) to the Agreement was last amended by Decision No 2/2011 of the EU-Swiss Joint Committee<sup>1</sup> and should be updated to take into account new legal acts of the European Union and Switzerland since that date,

HAS ADOPTED THIS DECISION:

#### Article 1

Annex III (Mutual recognition of professional qualifications) to the Agreement shall be amended in accordance with the Annex to this Decision.

## Article 2

This Decision is established in the Bulgarian, Croatian, Czech, Danish, Dutch, English, Estonian, Finnish, French, German, Greek, Hungarian, Italian, Latvian, Lithuanian, Maltese, Polish, Portuguese, Romanian, Slovak, Slovenian, Spanish and Swedish languages, the texts in each of these languages being equally authentic.

#### Article 3

This Decision shall enter into force on the first day of the second month following its adoption by the EU-Swiss Joint Committee.
