Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EC) No 883/2004 of the European Parliament and of the Council of 29 April 2004 on the coordination of social security systems<sup>1</sup>, and in particular Article 75 thereof.

Whereas:

- (1) In its Decisions of 21 October 2010<sup>2</sup> and 7 March 2011<sup>3</sup>, the Council appointed the members and alternate members of the Advisory Committee for the Coordination of Social Security Systems for the period ending on 19 October 2015.
- (2) A seat as alternate member in the employers' representatives category has fallen vacant as a result of the resignation of Ms Elizabeth ZIMMERER.
- (3) The government of Austria has nominated a candidate for the vacant seat,
