Subject: Draft Council Decision repealing Decision 2011/492/EU concerning the conclusion of consultations with the Republic of Guinea-Bissau under Article 96 of the ACP-EU Partnership Agreement  
- Adoption

1. On 18 July 2011, the Council of the European Union decided to take appropriate measures following the conclusion of the consultations held with the Republic of Guinea-Bissau under Article 96 of the ACP-EU Partnership Agreement by means of Council Decision 2011/492/EU<sup>1</sup>. That Decision was amended and its period of application was prolonged several times. On 14 July 2014 the Council adopted Decision 2014/467/EU<sup>2</sup> extending the validity of Decision 2011/492/EU and suspending the application of its appropriate measures.
2. On 26 February 2015, the Commission forwarded to the Council a proposal for a Council Decision repealing Decision 2011/492/EU concerning the conclusion of consultations with the Republic of Guinea-Bissau under Article 96 of the ACP-EU Partnership Agreement<sup>3</sup>.

3. The ACP Working Party discussed the abovementioned proposal and agreed on the text of the draft Council Decision on 6 March 2015.
4. In accordance with paragraph 3 of the Annex to the Internal Agreement for the implementation of the ACP-EC Partnership Agreement<sup>4</sup>, the Decision should be adopted by the Council acting by qualified majority.
5. The Permanent Representatives Committee is accordingly invited to recommend that the Council:
  - adopt the Decision as set out in document 6866/15 after finalisation by the legal/linguistic experts using, if necessary, a written procedure;
  - agree to communicate the letter in the Annex to this Decision to the authorities of the Republic of Guinea-Bissau;
  - decide to publish the Decision and the attached notification letter in the Official Journal of the European Union.
