Subject: Proposal for transfer of appropriations No DEC 35/2013 within Section III -

Commissions - of the general budget for 2013

1. On 23 October 2013, the Commission submitted to the Council proposal for transfer of appropriations No DEC 35/2013.

The purpose of this proposal is to transfer a total amount of EUR 18 million in commitment appropriations from Articles 05 06 01 (*International agricultural agreements*), 07 02 01 (*Contribution to multilateral and international environment and climate agreements*), 07 03 07 (*LIFE*+ (*Financial Instrument for the Environment* - 2007 to 2013)), 07 12 01 (*Implementation of Union policy and legislation on climate action*) and 17 03 19 (*Preparatory action - Fruit and vegetable consumption*), and Items 05 04 05 02 (*Operational technical assistance*), 17 04 01 01 (*Animal disease eradication and monitoring programmes and monitoring of the physical conditions of animals that could pose a health risk linked to an external factor - New measures*) and 17 04 04 01 (*Plant-health measures - New measures*) to Article 18 03 04 (*Emergency measures in the event of mass influxes of refugees*), as recorded in document 15240/13 FIN 672.

- 2. The transfer is being proposed to allow the Union to support the efforts of Member States directly concerned by the on-going migratory pressure.
- 3. <u>The Budget Committee</u> examined this proposal for a transfer at its meeting on 29 October 2013.
- 4. Following that examination, <u>the Budget Committee</u> agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
 - the proposed transfer of appropriations;
 - the draft letter in ANNEX to that effect.
