### **3. Relations with the Hague Conference**

#### **(c) The Judgments Project**

The Commission representative presented an information note from the Services of the Commission<sup>1</sup> containing a certain number of texts to be discussed at the next meeting of the Working Group at The Hague in February 2015.

She outlined the various issues which had been discussed between the members of the Working Group since the October meeting in Hong Kong with the focus again being put on the question of the criteria to be assessed at the time of recognition and enforcement.
