The Presidency submitted a revised compromise text to the SCA (doc. 6792/15) with the view to accommodate the issues raised by delegations at the SCA on 2 March 2015 or at the recent WP meetings as well as comments submitted in writing.

The SCA welcomed the efforts that have been made by the Presidency to accommodate the concerns of delegations.

The Presidency will further reflect on the remaining key issues, on the basis of observations raised by several delegations. The Presidency also welcomed the fact that many delegations could support the current drafting related to the section on imports of organic products.

The Presidency circulated the questions (doc. 6975/15) that will be tackled at the "Agriculture and Fisheries" Council on 16 March.
