Accordingly, there is no requirement for the Member States to be authorised to this extent to ratify the Protocol in the interests of the Union, and Member States should be able to consider ratification of the Protocol in their own right. Further, the United Kingdom considers that this draft Decision, being a measure proposed pursuant to Title V of Part Three of the Treaty on the Functioning of the European Union, is subject to Protocol (No 21) to the Treaties on the position of the United Kingdom and Ireland in Respect of the Area of Freedom, Security and Justice. The United Kingdom does not consider that it is automatically bound, as suggested by Recital (9), to participate in the Council Decision simply on account of its participation on Directive 2011/36/EU on preventing and combating trafficking in human beings and protecting its victims, and Directive 2012/29/EU establishing minimum standards on the rights, support and protection of victims of crime. We consider that the opt-in applies to this measure and we have not opted in."

"The Czech Republic wishes to stress the political significance of the 2013-2017 Action Plan and express its full support for the adoption of its content.

However, from the Czech Republic's point of view, Article 218(9) TFEU is not the correct procedural legal basis for the adoption of the 2013-2017 Action Plan, neither for the adoption of similar acts in a similar context, because these constitute important policy documents with political, but not legal effects. The relationship between the mentioned Action Plan and the Regulation (EU) No 232/2014 establishing a European Neighbourhood Instrument (ENI) cannot change the above stated fact, since it is too vague to cause legal effects of the Action Plan in the sense of the judgement in case C-399/12 Germany v. Council. In the view of the Czech Republic, the interpretation given to Article 218(9) by the Court of Justice of the EU in the above referred case cannot be further extended to cover the current situation and the status of the Action Plan or similar political documents adopted in the framework of other association agreements."
