Subject: Draft COUNCIL DECISION appointing an alternate member of the Governing Board of the European Agency for Safety and Health at Work for Slovakia

1. The Council appointed the members and alternate members of the Governing Board of the European Agency for Safety and Health at work, by its Decisions of 2 December 2013¹, of 12 June 2014², of 18 November 2014³, 15 December 2014⁴ and of 16 March 2015⁵.

However, it remained to appoint certain members and alternate members at a later stage.

- 2. Pursuant to Article 8(2) of Council Regulation (EC) 1112/2005, members and alternate members are appointed by the Council from the members and alternate members of the Advisory Committee on Safety and Health at Work, the membership of which was last renewed on 22 April 2013.⁶
- 3. A nomination, sent by the employers' organisation BUSINESSEUROPE, of an alternate member of the renewed Governing Board has been received by the Council Secretariat, as set out in the draft Council Decision in doc. 7649/15⁷.
- 4. The Permanent Representatives Committee could therefore suggest that the Council:
 - (a) adopt the Council Decision appointing an alternate member of the Governing Board of the European Agency for Safety and Health at Work for Slovakia, as an "A" item, and
 - (b) decide to publish the decision for information in the Official Journal of the European Union.
