	 Appointment of Ms Margit VADKERTI, member for Hungary, in place of Ms Katalin KISSNÉ BENCZE, who has resigned

- 1. <u>The General Secretariat of the Council</u> has been informed of the resignation of Ms Katalin KISSNÉ BENCZE as member of the above Committee in the government representatives category (for Hungary).
- 2. Under Article 27 of Regulation (EEC) No 1612/68 on freedom of movement for workers within the Community, members and alternate members are appointed by the Council.

3. In accordance with the usual procedure, the Government of Hungary has nominated the following candidate for the remainder of the current term of office, ending on 24 September 2016:

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Council Regulation (EEC) No 1612/68 of 15 October 1968 on freedom of movement for workers within the Community¹, and in particular Articles 26 and 27 thereof,

Whereas:

- (1) In its Decision of 25 September 2014², the Council appointed the members and alternate members of the Advisory Committee on Freedom of Movement for Workers for the period ending on 24 September 2016.
- (2) A seat as member in the government representatives category has fallen vacant as a result of the resignation of Ms Katalin KISSNÉ BENCZE.
- (3) The Government of Hungary has submitted a nomination for the vacant seat,

HAS ADOPTED THIS DECISION:
