Subject: Proposal for a Council Regulation amending Regulation (EU, Euratom) No  
1311/2013 laying down the multiannual financial framework for the years  
2014-2020  
- *Adoption*

---

1. On 20 January 2015, the Commission submitted the above-mentioned proposal to the Council. The proposed revision of the multiannual financial framework is foreseen in Article 19 of Council Regulation (EU, Euratom) No 1311/2013 laying down the multiannual financial framework for the years 2014-2020 in the case of a late adoption of operational programmes in the area of shared management and especially cohesion. This Article stipulates that "the revision concerning the transfer of unused allocation for the year 2014 shall be adopted before 1 May 2015".

2. On 13 February 2015, the Permanent Representatives Committee reached a unanimous agreement in principle on the text of the draft Council Regulation as revised by the lawyer-linguists, set out in doc. 5479/15 FIN 49 CADREFIN 5 REGIO 7 FSTR 6 FC 7 SOC 21 AGRISTR 2 PECHE 25 JAI 38 ASIM 3.
3. On 17 February 2015, the Council confirmed the agreement in principle on the text of the draft Council Regulation amending Regulation (EU, Euratom) No 1311/2013 laying down the multiannual financial framework for the years 2014-2020 as revised by the lawyer-linguists and agreed to forward this text<sup>1</sup> to the European Parliament for its consent.
4. The European Parliament is expected to adopt its consent<sup>2</sup> on the draft Council Regulation amending Regulation (EU, Euratom) No 1311/2013 laying down the multiannual financial framework for the years 2014-2020 at its Plenary session on 15 April 2015.
5. The Permanent Representatives Committee is therefore invited to recommend the Council to adopt the text of the draft Council Regulation amending Regulation (EU, Euratom) No 1311/2013 laying down the multiannual financial framework for the years 2014-2020, as set out in doc. 5479/15 FIN 49 CADREFIN 5 REGIO 7 FSTR 6 FC 7 SOC 21 AGRISTR 2 PECHE 25 JAI 38 ASIM 3.
