## I. VOTE

On 28 April 2015, since no amendment had been adopted by the Parliament, the President of the European Parliament declared the <u>Council's position at first reading approved</u>.

The text of the European Parliament's legislative resolution is annexed to this note.

## II. ADOPTION OF LEGISLATIVE ACTS FOLLOWING THE EUROPEAN PARLIAMENT'S SECOND READING

Since the European Parliament has approved the Council's position at first reading, the act in question is deemed to have been adopted in the wording which corresponds to the Council's position at first reading, as provided for in Article 294 (7)(a) of the TFEU.

After signature by the President of the European Parliament, the President of the Council and the Secretaries-General of the two Institutions, the act in question will be published in the *Official Journal* of the European Union.

European Parliament legislative resolution of 28 April 2015 on the Council position at first reading with a view to the adoption of a regulation of the European Parliament and of the Council amending Regulation (EC) No 223/2009 on European statistics (05161/2/2015 – C8-0073/2015 - 2012/0084(COD)

(Ordinary legislative procedure: second reading)

The European Parliament,

- having regard to the Council position at first reading (05161/2/2015 C8-0073/2015),
- having regard to the reasoned opinions submitted, within the framework of Protocol No 2 on the application of the principles of subsidiarity and proportionality, by the Spanish Congress of Deputies and the Spanish Senate and the Austrian Federal Council, asserting that the draft legislative act does not comply with the principle of subsidiarity,
- having regard to the opinion of the European Central Bank of 6 November 2012<sup>1</sup>,
- having regard to its position at first reading<sup>2</sup> on the Commission proposal to Parliament and the Council (COM(2012)0167),
- having regard to Article 294(7) of the Treaty on the Functioning of the European Union,
- having regard to Rule 76 of its Rules of Procedure,
- having regard to the recommendation for second reading of the Committee on Economic and Monetary Affairs (A8-0137/2015),
- 1. Approves the Council position at first reading;
- 2. Notes that the act is adopted in accordance with the Council position;
- 3. Instructs its President to sign the act with the President of the Council, in accordance with Article 297(1) of the Treaty on the Functioning of the European Union;
