## THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Regulation (EU) No 492/2011 of the European Parliament and of the Council of 5 April 2011 on freedom of movement for workers within the Union<sup>1</sup>, and in particular Articles 23 and 24 thereof.

Whereas:

- In its Decision of 25 September 2014<sup>2</sup>, the Council appointed the members and alternate members of the Advisory Committee on Freedom of Movement for Workers for the period ending on 24 September 2016.
- (2) A seat as alternate member in the employers' representatives category has fallen vacant as a result of the resignation of Mr Paolo TOMASSETTI.
- (3) The Government of Italy has submitted a nomination for the vacant seat,
