Subject:	Cooperation with the judiciary and legal practitioners - Response on the evaluation of the e-Justice Portal

On behalf of the CCBE I would like to thank the Working Party on e-Justice for consulting the CCBE during the process of evaluation of the content of the e-Justice Portal.

The CCBE has carefully reviewed the various sections of the website and, besides the observations listed below, our general conclusion is that the content and length of most of the items that are currently included correspond to overall needs. The existing portal constitutes an excellent body of information on a diverse range of topics of interest to, among others, legal professionals.

However, looking towards the future, the CCBE considers that the Portal should move forward, beyond being mainly a point of access to (static) information, to also include (dynamic) tools that facilitate access to justice for EU citizens or otherwise improve the administration of justice. We are convinced that if the portal is able to deliver such value added services, it will be much easier to attract a broader range of users. There are already different products being developed within various e-justice projects, and the CCBE considers it should be a priority of the Commission to ensure that these products are fully integrated into the Portal and made available to their target audience as soon as possible.

This should also be an element of continuing importance within future e-justice funding programmes. A good example of such an existing tool which should be incorporated as soon as possible within the Portal is the European Training Platform recently developed by the CCBE for use by lawyers (and which could in theory be used by other parts of the legal profession in due course).

The CCBE also recommends looking into more attractive ways to present the information available on the Portal. As pointed out in the observations below, some information is rather difficult to find and you already have to be acquainted with EU legal affairs in order to navigate through the large quantity of information. There is a need for a communication plan which not only takes into account possible changes to the overall lay-out of the website, but also investigates novel ways of attracting users through, for example, the use of apps to guide people through Portal content.

Besides these general comments, the CCBE would like to bring to your attention some practical issues we encountered when evaluating the Portal:

(a) The Portal should reflect recent legislative changes to the procedural safeguards for suspects and defendants in criminal proceedings, namely (a) the right to interpretation and translation, (b) the right to information, and (c) the right of access to a lawyer.

(b) Legal aid in criminal matters - a Directive is currently being discussed, and depending on the outcome of the discussions, this part of the portal may need to be updated;

(c) It may be best to present the home-page information in 4 boxes rather than 4 boxes and a side bar of issues;

(d) It is important to recognise (and take steps to address) that for information to have value and be trusted it needs to be accurate and kept up-to-date. At the moment in almost all sections there are still some country files missing or the information is only available in one language. Moreover, the CCBE has been informed that some country reports are not accurate and need to be corrected (for example, see attached ANNEX 1 for the responses we received from the Austrian and Polish Bars in relation to the sections about their countries that need to be corrected);

(e) The "latest news section" could be placed in another category (rather than taking up 25-30 % of the home page screen; and

(f) Certain headings, for example "tools for courts and practitioners", contain a significant quantity of useful information which may not be obvious from the heading.

I hope you find these comments useful and wish to indicate that the CCBE remains at your disposal in case you need any further information.
