 - State of play and further steps

The Presidency informed the SCA on the outcome of the discussions that took place during the "Agriculture and Fisheries" Council on 11 May on this file. The Presidency stressed that, although many delegations were ready to go for a general approach, the Council could not conclude, in particular because of the divergent views expressed by Ministers on the two sensitive issues on "residues" and "controls". These issues need to be further discussed and solved. The Presidency indicated that documents 8322/15, 8576/15 and the room document distributed during the Council meeting on 11 May should serve as a basis for further discussions. The Presidency urged delegations to show some flexibility in order to reach a general approach at the Council in June.

While the note on future work set out in doc. 6587/15 + COR 1 met with a large support, delegations formulated several comments. <u>The Presidency</u> will reflect how best to take them into account with a view to having this note endorsed at the SCA in Riga.

Preparation for agreement at first reading

<u>The Presidency</u> updated delegations on the state of play with the financial discipline proposal and the SCA agreed in principle that, in the case EP's COMAGRI approves the Commission's proposal without amendments on 28 May, the SCA chair will send a letter to the COMAGRI chair informing him that if no amendments to the Commission's proposal are introduced and adopted in the EP plenary (9 June), the Council will adopt the legislative act accordingly.
