Subject: Governing Board of the European Foundation for the Improvement of Living and Working Conditions  
Appointment of Ms Despoina MICHALIDOU, member for Greece, in place of Ms Stamatia PISIMISI, who has resigned

---

1. The General Secretariat of the Council has been informed of the resignation of Ms Stamatia PISIMISI as member of the Governing Board of the above Foundation in the government representatives category (for Greece).
2. Under Article 6 of Regulation (EEC) No 1365/75, as amended by Regulation (EC) No 1111/2005, members and alternate members of the Governing Board are appointed by the Council.

3. In accordance with the usual procedure, the government of Greece has nominated the following candidate to replace the resigning member for the remainder of the current term of office, ending on 30 November 2016:

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EEC) No 1365/75 of 26 May 1975 on the creation of a European Foundation for the Improvement of Living and Working Conditions<sup>1</sup>, and in particular Article 6 thereof,

Whereas:

- (1) In its Decisions of 2 December 2013<sup>2</sup> and of 8 July 2014<sup>3</sup>, the Council appointed the members and alternate members of the Governing Board of the European Foundation for the Improvement of Living and Working Conditions for the period ending on 30 November 2016.
- (2) A seat as member of the Governing Board of that Foundation in the government representatives category has fallen vacant as a result of the resignation of Ms Stamatia PISIMISI.
