THE POLITICAL AND SECURITY COMMITTEE,

Having regard to the Treaty on European Union and in particular the third paragraph of Article 38 thereof,

Having regard to the Council Joint Action 2008/124/CFSP of 4 February 2008 on the European Union Rule of Law Mission in Kosovo, EULEX KOSOVO<sup>2</sup> and in particular Article 12 (2) thereof,

Whereas:

- (1) Pursuant to Article 12 (2) of Joint Action 2008/124/CFSP, the Political and Security Committee (PSC) is authorised, in accordance with Article 38 of the Treaty, to take the relevant decisions for the purpose of exercising political control and strategic direction of the European Union Rule of Law Mission in Kosovo (EULEX KOSOVO), including the decision to appoint a Head of Mission.
- (2) On 12 June 2014, the Council adopted Decision 2014/349/CFSP<sup>1</sup> amending Joint Action 2008/124/CFSP and extending the duration of EULEX KOSOVO until 14 June 2016.
- (3) On 9 October 2014, the PSC adopted Decision 2014/707/CFSP (EULEX KOSOVO/2/2014)<sup>2</sup>, appointing Ambassador Gabriele MEUCCI as Head of Mission of EULEX KOSOVO until 14 June 2015.
- (4) On 15 June 2015, the High Representative of the Union for Foreign Affairs and Security Policy proposed the extension of the mandate of Ambassador Gabriele MEUCCI as Head of Mission of EULEX KOSOVO until 14 June 2016,

HAS ADOPTED THIS DECISION:
