Sir,

In reply to your letter of 7 May 2015 concerning the nomination of members to replace ten members of the Court of Auditors, nine of whom will reach the end of their term of office on 6 May 2016 and one on 1 November 2016, I inform you that the General Secretariat of the Council has already requested the Member States concerned to send their proposals no later than 16 November 2015 and 16 May 2016 respectively.

In order to ensure continuity of the Court of Auditor's work, the Council Decisions appointing the members of the Court should be adopted no later than the beginning of April 2016 (nine members) and October 2016 (one member) respectively. To that end, the procedure for the appointment of the members should start in sufficient time for the Council to take its decision to consult the European Parliament early in December 2015 and in June 2016 respectively.
