During the examination of the European Agenda on Migration (EAM), which was generally welcomed, most Ministers focused their interventions on the Commission proposal on relocation. All delegations indicated that, on the basis of the solidarity principle, they were ready to make an effort. However, delegations remained divided, in particular on its compulsory nature and the repartition key for the contribution of each Member State. The Presidency indicated that consultations should be pursued and invited delegations to make a special effort in order to reach an agreement, with a view to helping MS under particular migratory pressure, in the weeks to come.
