Note 1: BIS amounting to €11,400,000 for 12-month extension of EUCAP Sahel Mali was already approved by RELEX Counsellors Working Group in 2014. This action is partially funded with appropriations carried over from 2014 to 2015 budget according to Article 13(2) of the Financial Regulation.

Note 2: Council Decision 2014/912/CFSP was adopted by the Council and the funds for UNODA – SAHEL project were committed in 2014. However, due to the refusal by the beneficiary of the "UNODA – SAHEL" project to countersign the contract at the end of 2014, the funds have been de-committed in 2015 and the project is financed with 2015 budget appropriations.

Note 3: BISs amounting to €2,528,069 for Support of OPCW and €1,274,398.85 for support to the proposal for an International Code of Conduct on Outer Space Activities were already approved by RELEX Counsellors Working Group in 2014. These actions are funded with appropriations carried over from 2014 to 2015 budget according to Article 13(2) of the Financial Regulation.
