Thank you for your message sent today 22 May 2015, addressed to the Access to documents service of the EEAS and a copy of which was sent to the Access to documents Unit of the General Secretariat of the Council.

The Access to documents service of the EEAS was in contact with the Access to documents Unit of the GSC following the receipt by the EEAS of your request for public access to documents dated 5 March 2015. The GSC informed the colleagues at the EEAS that the Council does not hold any documents matching your request relating to the briefing documents but that the Council does hold general files relating to the EU police support mission known as EUPOL-COPS in the West Bank and Gaza. The EEAS informed you of this with their letter dated 17 March 2015.

It seems however that there was a misunderstanding between the two services as to the follow-up of your request. The EEAS informed you that they have transferred your request to the GSC. We at the GSC however understood from the EEAS colleagues that they would ask you to address yourself to the Council/GSC. Not having heard anything from you since then, the GSC has so far not registered your request for public access.

Referring to your request for public access to Council documents, registered by the Access to documents unit of the General Secretariat of the Council on 22 May 2015, and to our letter dated 27 May 2015, the General Secretariat would like to indicate as follows:

The General Secretariat has continued¹ the examination of your request concerning general files prepared between 1 January 2004 and 1 January 2007 relating to the EU police support mission known as EUPOL COPPS in the Palestinian territories and can indicate the following:

Preliminary remark:

EU Classified Information (EUCI) is classified at the following levels, among others:²

The General Secretariat of the Council has examined your request on the basis of the applicable rules: Regulation (EC) No 1049/2001 of the European Parliament and of the Council regarding public access to European Parliament, Council and Commission documents (OJ L 145, 31.5.2001, p. 43) and the specific provisions concerning public access to Council documents set out in Annex II to the Council's Rules of Procedure (Council Decision No 2009/937/EU, OJ L 325, 11.12.2009, p. 35).

"RESTREINT UE/EU RESTRICTED": this classification is applied to information and material the unauthorised disclosure of which could be disadvantageous to the interests of the European Union or of one or more of its Member States.

You may have public access to document 15027/05. You may also have access to the fully declassified version of document 15348/05 RESTREINT UE/EU RESTRICTED which can be found in document 15348/05 DCL 1.

The General Secretariat has also identified document **13526/05** to which you may have full public access.

Furthermore, please find attached a partially accessible version of document 13757/05.³ However, I regret to inform you that full access cannot be given for the reasons set out below.

Document 13757/05 is a draft "I/A" Item Note from the General Secretariat to the Permanent Representatives Committee and the Council relating to the draft Council Joint Action on the European Union Police Mission for the Palestinian Territories, EUPOL COPPS. The document sets out the text of the draft Council Joint Action and the financial statement related to the expenditure of the mission.

The document has content which enables the identification of certain persons working for the mission. This is personal data within the meaning of Article 2(a) of Regulation (EC) No 45/2001⁴.

The data protection rules at EU level provide that when the personal data collected is to be used for a different purpose, including disclosure to the public, a balance needs to be established between the public interest in having access to such data and the legitimate right of individuals to protect their personal data.⁵

After carefully considering all the principles related to this request, on balance the General Secretariat has concluded that disclosure of the personal data contained in the document would undermine the protection of privacy and the integrity of the identified individuals. As a

consequence, the General Secretariat has to refuse access to those parts of the document which enable the identification of certain persons working for the mission.⁶

Moreover, if identified, the safety of the persons in question would be at risk. The mission performs its activities under particularly challenging circumstances. If the identity of the persons in question was known, they would run a high risk of attracting hostile attention. Full disclosure of the document would therefore undermine the protection of the public interest as regards public security. Also for this reason, the General Secretariat has to refuse access to those parts of the document which enable the identification of certain persons working for the mission.⁷

Document 13047/2/05 REV 2 is classified RESTREINT UE/EU RESTRICTED. This document sets out the draft concept of operations (CONOPS) for the EU Police Mission in the Palestinian territories (EUPOL COPPS) The CONOPS was elaborated by the relevant preparatory bodies of the Council in the light of the Council's agreement on the follow-on to the EU mission.

The document provides an assessment of the Palestinian Authority's police forces and their capabilities, as well as a number of internal assessments on the political context. Furthermore, it sets out a thorough analysis of the mission's infrastructure and methodologies, including finance, logistics, communications, legal requirements, training and core information on command and control of the operations.

Documents 13571/05 and 13571/1/05 REV 1 are also classified RESTREINT UE/
EU RESTRICTED. These documents set out the advice of the Committee for Civilian Aspects of
Crisis Management (CivCom) on the draft Concept of Operations (CONOPS) for the EU Police
Mission in the Palestinian territories (EUPOL COPPS). They reveal sensitive details of the ongoing mission, internal assessments of the situation on the ground and strategic objectives of the
EU vis-à-vis the operation.

Document 15053/1/05 REV 1 is also classified RESTREINT UE/ EU RESTRICTED. It sets out a draft Operational Plan (OPLAN) for the EU Police Mission in the Palestinian territories (EUPOL COPPS). It provides an assessment of the Palestinian Authority's police forces and their capabilities, as well as a number of internal assessments on the political context. Moreover, it sets out the mission's political and operational objectives as well as detailed plans for the proper functioning of the mission, its infrastructure and methodologies.

The General Secretariat considers that the information contained in the above-mentioned documents is of a strategic and operational nature. Disclosure of such sensitive information concerning this on-going mission would seriously undermine not only the proper functioning and outcome of this specific operation but also the functioning and outcome of other current and future operations, put at risk the staff deployed in the field and prejudice the EU's relations with the Palestinian authorities. As a consequence, the General Secretariat has to refuse public access to these documents.⁸

You may however have access to document 13047/2/05 REV 2 EXT 1, the partially declassified version of document 13047/2/05 REV 2 RESTREINT UE/EU RESTRICTED, and to document 15053/1/05 REV 1 EXT 1, the partially declassified version of document 15053/1/05 REV 1 RESTREINT UE/EU RESTRICTED.

As to documents 13571/05 and 13571/1/05 REV 1, although they contain parts of differing sensitivity, even the least sensitive parts are covered by the above-mentioned exceptions to the principle of transparency. Partial access pursuant to Article 4(6) of the Regulation is therefore not possible for these documents.

In addition to the documents mentioned in our letter dated 27 May 2015, the General Secretariat has identified nine Coreu messages as being covered by your request for public access. These Coreu messages set out minutes of the meetings of the Political and Security Committee (PSC) held in 2004 and 2005, i.e. at a time when PSC participated in the discussions concerning the preparation of EUPOL COPPS.

PSC minutes are set out in Coreu messages which are all classified **RESTREINT UE/EU RESTRICTED**. In the identified Coreus, the General Secretariat has only considered those parts of the text which relate to the preparation of EUPOL COPPS.

Following the examination of these documents, the General Secretariat has come to the conclusion that all nine Coreus can be partially declassified (i.e. the entirety of those parts of the text which relate to the preparation of EUPOL COPPS). You will find attached the partially declassified Coreus which have the following numbers:

The General Secretariat has finalised¹⁰ the examination of your request concerning general files prepared between 1 January 2004 and 1 January 2007 relating to the EU police support mission known as EUPOL COPPS in the Palestinian territories and can indicate the following:

Furthermore, partial declassification is possible for document **15340/05 RESTREINT UE/EU RESTRICTED**. ¹² However, I regret to inform you that full access cannot be given for the reasons set out below.

Document 15340/05 RESTREINT UE/ EU RESTRICTED sets out a draft Operational Plan (OPLAN) for the EU Police Mission in the Palestinian territories (EUPOL COPPS). It provides an assessment of the Palestinian Authority's police forces and their capabilities, as well as a number of internal assessments on the political context. Moreover, it sets out the mission's political and operational objectives as well as detailed plans for the proper functioning of the mission, its infrastructure and methodologies.

The General Secretariat considers that the information contained in this document is of a strategic and operational nature. Disclosure of such sensitive information concerning this on-going mission would seriously undermine not only the proper functioning and outcome of this specific operation but also the functioning and outcome of other current and future operations, put at risk the staff deployed in the field and prejudice the EU's relations with the Palestinian authorities. Regarding document **10220/05 RESTREINT UE/EU RESTRICTED**, I regret to inform you that public access cannot be given for the reasons set out below.

Document 10220/05 RESTREINT UE/EU RESTRICTED sets out options for a follow-on for the EU Police Mission in the Palestinian territories (EUPOL COPPS). It reveals sensitive details of the on-going mission, internal assessments of the situation on the ground and of the Palestinian Authority's police forces and their capabilities as well as strategic objectives of the EU vis-à-vis the operation.

The General Secretariat considers that the information contained in the above-mentioned document is of a strategic and operational nature. Disclosure of such sensitive information concerning this on-going mission would seriously undermine not only the proper functioning and outcome of this specific operation but also the functioning and outcome of other current and future operations, put at risk the staff deployed in the field and prejudice the EU's relations with the Palestinian authorities. As a consequence, the General Secretariat has to refuse public access to this document.¹⁴

The General Secretariat has examined whether partial access to document 10220/05 RESTREINT UE/EU RESTRICTED would be possible pursuant to Article 4(6) of the Regulation. However, it has concluded that all parts of the document are covered by the above-mentioned exceptions to the principle of transparency. Partial access is therefore not possible for this document.

Finally, the General Secretariat would like to point out that it does not hold documents issued by the mission itself. Following the launch of the European External Action Service (EEAS) in January 2011, all documents issued by CSDP missions were transferred from the Council to the EEAS.

Dear Sir/Madam

I am writing to request that the Council of the European Union review its recent decision not to grant me access to certain documents relating to the EU's policing mission in the occupied West Bank. The reference number for my access to documents request cited in previous messages I have received from the Council is Ref. 15/1387-mi-ADD1.

I believe that there is an overriding public interest in disclosing the documents I requested. To the best of my knowledge, the mission in question is the EU's first security operation in the occupied West Bank or Gaza. As it is financed by European taxpayers and the EU has obligations to ensure that international law is respected, it is surely vital that concerned individuals are allowed to scrutinise how the mission is being conducted. To ensure that this occurs, I believe that the EU needs to guarantee full transparency.

For that reason, I respectfully respect that that I be granted access to the documents in question in their entirety.

I would be grateful if you could confirm receipt of this message.
