### **EXPENDITURE**

#### **TITLE 02 — INTERNAL MARKET, INDUSTRY, ENTREPRENEURSHIP AND SMES**

##### **Article 02 03 03 — European Chemicals Agency — Chemicals legislation**

Paragraph 5 of the remarks is modified as follows:

In 2016, the Agency's "Revenue from fees and charges" and the surplus carried over from previous year will not be sufficient to cover for the expected expenditure, which implies the need of a subsidy from the Commission. The Union contribution for 2016 amounts to a total of EUR ~~72 805 000~~ **68 904 700**.

#### **TITLE 04 — EMPLOYMENT, SOCIAL AFFAIRS AND INCLUSION**

##### **Article 04 03 12 — European Agency for Safety and Health at Work (EU-OSHA)**

Paragraph 5 of the remarks is modified as follows:

The Union contribution for 2016 amounts to a total of EUR ~~14 679 000~~ **14 671 260**. An amount of EUR 16 000 coming from the recovery of surplus is added to the amount of EUR ~~14 663 000~~ **14 655 260** entered in the budget.

## **TITLE 06 — MOBILITY AND TRANSPORT**

### **Article 06 02 03 — European Maritime Safety Agency (EMSA)**

Item 06 02 03 01 — European Maritime Safety Agency (EMSA)

Paragraph 6 of the remarks is modified as follows:

The Union contribution for 2016 including anti-pollution measures amounts to a total of EUR ~~53 379 372~~ **53 363 369**. An amount of EUR 2 230 340 coming from the recovery of surplus, is added to the amount of EUR ~~51 149 032~~ **51 133 029** entered in the budget.

### **Article 06 02 04 — European Railway Agency (ERA)**

Paragraph 6 of the remarks is modified as follows:

The Union contribution for 2016 amounts to a total of EUR ~~26 000 000~~ **25 966 760**. An amount of EUR 787 000 coming from the recovery of surplus, is added to the amount of EUR ~~25 213 000~~ **25 179 760** entered in the budget.

## **TITLE 07 — ENVIRONMENT**

### **Article 07 02 06 — European Environment Agency (EEA)**

Paragraph 9 of the remarks is modified as follows:

The Union contribution for 2016 amounts to a total of EUR ~~36 309 240~~ **36 269 011**. An amount of EUR 752 386 coming from the recovery of surplus 2014 is added to the amount of EUR ~~35 556 854~~ **35 516 625** entered in the budget.

## **TITLE 09 — COMMUNICATIONS NETWORKS, CONTENT AND TECHNOLOGY**

### **Article 09 02 04 — Body of European Regulators for Electronic Communications (BEREC) — Office**

Paragraph 9 of the remarks is modified as follows:

The Union contribution for 2016 amounts to a total of EUR ~~4 246 000~~ **4 211 569**. An amount of EUR 174 000 coming from the recovery of surplus is added to the amount of EUR ~~4 072 000~~ **4 037 569** entered in the budget.

## **TITLE 11 — MARITIME AFFAIRS AND FISHERIES**

### **Article 11 06 64 — European Fisheries Control Agency (EFCA)**

Paragraph 5 of the remarks is modified as follows:

The Union contribution for 2016 amounts to a total of EUR ~~9 217 000~~ **9 210 220**. An amount of EUR 147 000, coming from the recovery of surplus, is added to the amount of EUR ~~9 070 000~~ **9 063 220** entered in the budget.

## **TITLE 17 - HEALTH AND FOOD SAFETY**

### **Article 17 03 11 — European Food Safety Authority (EFSA)**

Paragraph 7 of the remarks is modified as follows:

The Union contribution for 2016 amounts to a total of EUR ~~77 333 000~~ **77 094 220**. An amount of EUR 1 089 000 coming from the recovery of surplus is added to the amount of EUR ~~76 244 000~~ **76 005 220** entered in the budget.

## TITLE 18 — MIGRATION AND HOME AFFAIRS

### Article 18 02 07 — European Agency for the operational management of large-scale IT systems in the area of freedom, security and justice (eu.LISA)

Paragraph 6 of the remarks is modified as follows:

The Union contribution for 2016 amounts to a total of EUR ~~80 282 000~~ **79 833 626**.

### Article 18 06 02 — European Monitoring Centre for Drugs and Drug Addiction (EMCDDA)

Paragraph 5 of the remarks is modified as follows:

The Union contribution for 2016 amounts to a total of EUR ~~14 794 000~~ **14 789 140**. An amount of EUR 70 000 coming from the recovery of surplus is added to the amount of EUR ~~14 724 000~~ **14 719 140** entered in the budget.

## TITLE 33 — JUSTICE AND CONSUMERS

### Article 33 02 07 — European Institute for Gender Equality (EIGE)

Paragraph 6 of the remarks is modified as follows:

The Union contribution for 2016 amounts to a total of EUR ~~7 628 000~~ **7 624 220**. An amount of EUR 101 000 coming from the recovery of surplus is added to the amount of EUR ~~7 527 000~~ **7 523 220** entered in the budget.

**Article 33 03 04 — European Body for the Enhancement of Judicial Cooperation  
(EUROJUST)**

Paragraph 5 of the remarks is modified as follows:

The Union contribution for 2016 amounts to a total of EUR ~~43 409 737~~ **42 795 653**. An amount of EUR 591 000 coming from the recovery of surplus is added to the amount of EUR ~~42 818 737~~ **42 204 653** entered in the budget.

**TITLE 40 — RESERVES**

**CHAPTER 40 01 — RESERVES FOR ADMINISTRATIVE EXPENDITURE**

**Article 40 01 40 — Administrative reserve**

*Remarks*

The appropriations entered in this article are purely provisional and may only be used after their transfer to another budget line in accordance with the Financial Regulation.
