The Council adopted its position on draft amending budget No 3 to the general budget for 2015 by qualified majority, with the abstention of the United Kingdom delegation, in accordance with Article 314 of the Treaty on the Functioning of the European Union.

The Council was informed about the final compromise on a proposal for a regulation on the European Fund for Strategic Investments. The Regulation will be subject for adoption by the Council in a written procedure on 25 June 2015.

**5. Administrative cooperation**

- **Proposal for a Council Directive amending Directive 2011/16/EU as regards mandatory automatic exchange of information in the field of taxation**

The Council held an exchange of views on the state of play on this dossier, with a specific focus on the issues set out in the Presidency report to the Council. The Chair concluded by taking note of progress achieved since the Commission proposal was presented, as well as of concerns that some of the Member States have raised, which will have to be taken into consideration at technical level, given that work will be continued so as to enable the Council to reach an agreement in autumn 2015.

**6. Interest and Royalties Directive**
