Declaration by the Slovak Republic regarding Framework Decision 2003/577/JHA on the execution in the European Union of orders freezing property or evidence

The Slovak Republic hereby makes the following declaration:

Article 9(3):

'Certificates addressed to the Slovak judicial authorities must be in Slovak or accompanied by a translation into Slovak. The Slovak Republic will accept certificates under this legal act in respect of the Czech Republic in Czech.'

Declaration by the Slovak Republic regarding Council Framework Decision 2009/948/JHA on prevention and settlement of conflicts of exercise of jurisdiction in criminal proceedings

The Slovak Republic hereby makes the following declaration:

Article 14(1):

'The Slovak Republic declares that, for the purposes of the procedure of taking contact in accordance with Chapter 2, Slovak (and, in respect of the Czech Republic, Czech) may be used.'

Notification by the Slovak Republic regarding Framework Decision 2008/909/JHA on the application of the principle of mutual recognition to judgments in criminal matters imposing custodial sentences or measures involving deprivation of liberty for the purpose of their enforcement in the European Union

The Slovak Republic hereby issues the following notification:
