| Subject: | Proposal for transfer of appropriations No 1/2015 within Section X - European External Action Service - of the general budget for 2015 |

 On 27 August 2015, the European External Action Service (EEAS) submitted to the Council proposal for transfer of appropriations No 1/2015.

The purpose of this proposal is to transfer non-differentiated appropriations for a total amount of EUR 3.76 million, of which:

- a) EUR 0.48 million from Item 2000 (*Rents and annual lease payments*) to Article 110 (*Statutory staff*) and to Article 120 (*External staff and outside services*)
- b) EUR 1.48 million from Item 2000 (*Rents and annual lease payments*) to Article 201 (*Cost relating to buildings*), to Article 220 (*Conferences, congresses and meetings*) and to Article 223 (*Miscellaneous expenses*).
- c) EUR 1.80 million from Item 2000 (*Rents and annual lease payments*) to Item 3001 (*External staff and outside services*).

- 2. The transfer is being proposed to:
 - a) reinforce the lines related to family allowances for staff members, to traineeships, to interim staff and to special advisors and to military seconded national experts.
 - reinforce the lines related to security and surveillance of buildings in Brussels, to organisations of conferences and congresses, to interinstitutional cooperation and to legal expenses.
 - c) cover the increased needs for the remuneration of local agents in delegations due to the depreciation of the euro against other currencies.
- The <u>Budget Committee</u> examined the proposal for a transfer at its meeting on 10 September 2015.
- 4. Following that examination, the <u>Budget Committee</u> agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
 - the proposed transfer of appropriations;
 - the draft letter in the ANNEX to that effect.
