Subject: Proposal for transfer of appropriations No DEC 28/2015 within Section III - Commission - of the general budget for 2015

---

1. On 8 September 2015, the Commission submitted to the Council proposal for transfer of appropriations No DEC 28/2015.

The purpose of this proposal is to transfer an amount of:

- EUR 30 million in commitment appropriations (c/a) from Article 01 03 02 (*Macro-financial assistance*) to Item 21 03 01 03 (*Mediterranean countries - Confidence building, security and the prevention and settlement of conflicts*);
- EUR 12.5 million in c/a from Article 01 03 02 (*Macro-financial assistance*) and EUR 2.5 million in c/a from Article 40 02 42 (*Emergency Aid Reserve*) to Article 23 02 01 (*Delivery of rapid, effective and needs-based humanitarian aid and food aid*);

- EUR 1.7 million in payment appropriations (p/a) from Article 01 03 02 (*Macro-financial assistance*) and EUR 13.3 million in p/a from Article 40 02 42 (*Emergency Aid Reserve*) to Article 23 02 01 (*Delivery of rapid, effective and needs-based humanitarian aid and food aid*),

as recorded in document 11753/15 FIN 592.

2. The transfer of EUR 30 million in c/a is being proposed to support the refugee population in Syria, Lebanon and Jordan, in relation to the Syria crisis and to the rise of the Islamic State of Iraq and the Levant (ISIL). The transfer of EUR 15 million both in c/a and p/a is being proposed to provide humanitarian assistance to respond to the increased needs in the crisis in Syria and Iraq.
3. The Budget Committee examined this proposal for a transfer at its meeting on 10 September 2015.
4. Following that examination, the Budget Committee agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
  - the proposed transfer of appropriations;
  - the draft letter in the ANNEX to that effect.
