Committee of the Regions: Appointment of Mr Christian ILLEDITS, Landtagspräsident, as member and Mr Hans NIESSL, Landeshauptmann, as alternate member

Dear Sir.

Mr Hans NIESSL, Landeshauptmann, has been a member of the Committee of the Regions (CoR) since 25 January 2015. Mr Christian ILLEDITS, Landtagspräsident, has been an alternate member of the CoR since the same date. On account of the election of the Burgenland parliament on 31 May 2015 and the formation of the new parliament on 9 July 2015, Mr Hans NIESSL, Landeshauptmann, and Mr Christian ILLEDITS, Landtagspräsident, have declared in a letter to the President of the CoR that their mandates as member and alternate member respectively ended with effect from 9 July 2015.

On 23 July 2015 the Provincial Government of Burgenland decided to propose the appointment of Mr Christian ILLEDITS, Landtagspräsident, as a full member of the CoR to succeed Mr Hans NIESSL, Landeshauptmann for the remainder of the current term of office. It was furthermore decided to propose the appointment of Mr Hans NIESSL, Landeshauptmann, as an alternate member of the CoR to succeed Mr Christian ILLEDITS, Landtagspräsident.

As President of the Burgenland parliament, Mr Christian ILLEDITS holds an electoral mandate in a regional, democratically elected representative body. As Governor of Burgenland, Mr Hans NIESSL is politically accountable to a democratically elected representative body (the parliament of Burgenland). Both candidates thus satisfy the conditions under European law for the positions of member and alternate member respectively of the CoR.

I should now like to inform you that the Austrian Federal Government has decided to appoint Mr Christian ILLEDITS, Landtagspräsident, as a full member and Hans NIESSL, Landeshauptmann, as an alternate member of the CoR.
