The Council's debate, based on two questions suggested by the Presidency, focused on the scope of the Regulation (the establishment of the list of invasive alien species) and the possibility to cooperate at the level of EU bio-geographic regions.

At the end of the debate, the Presidency highlighted some elements emerging from the debate:

- the need to review some of the features of the list of such species (their number and origin) and to prioritise actions against invasive species on the basis of scientific assessment;
- the importance of regional cooperation as an important element to ensure the prevention and management of the introduction and spread of invasive alien species.

<u>The Commission</u> expressed its readiness to work to review the number of invasive species to be included in the list and to prioritise them.
