Whereas the Commission should be authorised to open negotiations on and negotiate, on behalf of the Member States, the provisions that fall within the competence of the Member States of a Framework Agreement between the European Union and the European Atomic Energy Community and their Member States, of the one part, and the Republic of Armenia, of the other part,

HAVE ADOPTED THIS DECISION:

## Article 1

- 1. The Representatives of the Governments of the Member States hereby authorise the Commission to open negotiations on and negotiate, on behalf of the Member States, the provisions that fall within the competence of the Member States of a Framework Agreement between the European Union and the European Atomic Energy Community and their Member States, of the one part, and the Republic of Armenia, of the other part.
- 2. The negotiations shall be conducted on the basis, where applicable, of the negotiating directives set out in an addendum to Council Decision ... 1\*.
- 3. The negotiations shall be conducted in consultation with the Representatives of the Governments of the Member States meeting within the special committee designated by the Council pursuant to the Decision ...\*\*.
