Whereas:

- According to Decision 2002/187/JHA, Eurojust may conclude agreements or working (1) arrangements with the institutions, bodies and agencies set up by, or on the basis of, the Treaties. Such agreements or working arrangements may, in particular, concern the exchange of information, including personal data, and the secondment of liaison officers to Eurojust. Such agreements or working arrangements may only be concluded after consultation by Eurojust with the Joint Supervisory Body concerning the provisions on data protection and after the approval by the Council.
- In order to strengthen its capacity to work with the Office for Harmonisation in the Internal (2) Market established by Council Regulation (EC) No 207/2009¹, Eurojust has negotiated a Memorandum of Understanding between the Office for Harmonisation in the Internal Market and Eurojust (the 'Memorandum').
- (3) The Joint Supervisory Body of Eurojust gave a positive opinion on the Memorandum.

- (4) The Memorandum was approved by the College of Eurojust on 19 May 2015.
