Subject:	Proposal for transfer of appropriations No DEC 32/2015 within Section III - Commission - of the general budget for 2015		

1. On 30 September 2015, the Commission submitted to the Council proposal for transfer of appropriations No DEC 32/2015.

The purpose of this proposal is to transfer an amount of:

- EUR 175.0 million in commitment appropriation (c/a) from Article 40 02 42 (*Emergency Aid Reserve*) to Article 23 02 01 (*Delivery of rapid, effective and needs-based humanitarian aid and food aid*);
- EUR 1.5 million in payment appropriations (p/a) from Article 23 04 01 (EU Aid Volunteers Initiative Strengthening the Union's capacity to respond to humanitarian crises) and EUR 12.8 million in p/a from Article 40 02 42 (Emergency Aid Reserve) to Article 23 02 01 (Delivery of rapid, effective and needs-based humanitarian aid and food aid),

as recorded in document 12505/15 FIN 650.

- 2. A transfer of EUR 80 million in c/a is being proposed to support the refugee population in Turkey, Lebanon, Jordan and the Western Balkans (Serbia, former Yugoslav Republic of Macedonia), in relation to the Syria crisis. A transfer of EUR 65 million in c/a is being proposed to support the Internally Displaced Persons in Syria. A transfer of EUR 30 million in c/a is being proposed to cover the need of displaced populations in Iraq.
- 3. The <u>Budget Committee</u> examined this proposal for a transfer at its meetings on 1 and 5 October 2015.
- 4. Following that examination, the <u>Budget Committee</u> agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
  - the proposed transfer of appropriations;
  - the draft letter in the ANNEX to that effect.
