Annex

A. Mission Area

A. SITUATION

Background

- 1. The dramatic changes in Mali required a review of the actions the EU should undertake to support the return to a legitimate democratic government and the rule of law throughout the territory of Mali.
- 2. Through letters of 18 Sep 12, the President of the Malian Republic and the Prime Minister of both requested the assistance of the EU (Ref. P). The EU responded on 17 Oct 12 (Ref. T), proposing the deployment of a CSDP mission.
- 3. On 12 Oct 12, UNSC Resolution 2071 (Ref. R) invited regional and international organisations, including the EU, to provide coordinated assistance, expertise, training and capacity-building support to the Armed and Security Forces of Mali.
- 4. On 15 Oct 12, the Foreign Affairs Council (Ref. S) requested that planning for a possible CSDP military operation be pursued as a matter of urgency, in particular by developing a Crisis Management Concept (CMC) relating to the reorganisation and training of the Malian Armed Forces (MAF), the military part of the Malian Defence and Security Forces (MDSF), in close collaboration with the organisations, states and actors concerned.
- 5. On 28 Nov, the UNSG reported to the UNSC on the situation in Mali (Ref AA), including on the status of the AU and ECOWAS-led planning efforts.
- 6. On 10 Dec, the Council (Ref GG) approved the CMC, on which the PSC noted the EU Military Committee (EUMC) Advice (Ref. CC) and the Political-Military Group (PMG) Recommendations (Ref. DD) on 26 and 29 Nov respectively, and agreed both documents' recommendations. The Council also underlined the need to proceed swiftly with the planning process.
- 7. It is expected that the Republic of Mali will shortly send a letter of invitation to the EU.
- 8. It is expected that the Council will shortly decide to establish a EU Training Mission (EUTM) in Mali (Ref HH).

Financial

- 80. In accordance with the Council Decision establishing the Mission (Ref HH), the ATHENA Council Decision (Ref. F) and the ATHENA Financial Rules (Ref. K), you are to act on behalf of ATHENA, in relation to financing of the common costs of the mission.
- 81. You are to submit your proposals for the draft budget for common costs of the mission to the Special Committee via the ATHENA Administrator, at an early stage.
- 82. You are to specify in detail the financial implications of technical arrangements with all parties.
- 83. As authorising officer, you are to implement the appropriations related to the mission common costs and nations' borne costs. You may award contracts and enter into contracts on behalf of ATHENA.
- 84. You are authorised to adopt any measure which you deem necessary to implement the expenditure financed though ATHENA for this mission. You are to inform the ATHENA Administrator and the ATHENA Special Committee of such action.

85. Prior to the end of the mission you are to propose to the ATHENA Special Committee the final destination of the EU common funded infrastructure, equipment and assets (transfer, handover, selling or otherwise). You should take into account regional actors and financial return on investment.

Reporting

89. You are to:

- a. Submit the draft CONOPS and PSOR, and draft MPLAN and RoE as required to the PSC for agreement and subsequent approval by Council.
- b. Report routinely on a weekly basis (via your Mission Support Cell), and, directly and immediately regarding significant events, to the EUMC and to the PSC.
- c. Submit lessons observed on a 3-monthly basis and on completion of the mission, to EUMS for insertion into the EUMS ELMA database.
- d. Submit your Six-Monthly Report(s) to the EUMC and to the PSC.
- e. Submit a written report to the PSC, copied to the EUMC, on completion of the mission.
- f. Submit financial reports to the ATHENA Administrator in accordance with ATHENA rules and on request of the ATHENA Administrator/Special Committee.
