### **2. Proposal for a Directive of the European Parliament and of the Council on the enforcement of Directive 96/71/EC concerning the posting of workers in the framework of the provision of services [First reading]**

In spite of intensive negotiations on the basis of Presidency's revised compromise proposals, and of alternative joint compromise proposals presented by a group of delegations, the Council was not able to reach a general approach on the Directive. The Presidency undertook to reflect on the future handling of this dossier.

### **3. Youth Employment**

– Exchange of views

The Council held an exchange of views on youth employment. Delegations informed on the progress in implementing the Youth Guarantee Recommendation through their national implementation plans. Delegations also shared their national approaches, stressing in particular the need for quality education, support to young entrepreneurship, and prevention of the young becoming NEETs through coaching, counselling and guiding. Emphasis was also put on apprenticeships and traineeships. It was stressed that no improvement in youth employment figures could be made without effective structural reforms aiming at economic recovery and growth.

**Statement by the United Kingdom**

"The UK acknowledges and respects other Member States' support for this non-binding Declaration. And we strongly support efforts to tackle youth unemployment and to improve access to, and the quality of, apprenticeships. But the UK wishes to highlight that this is a Member State competence and therefore has some concerns about the prescriptive nature of this Declaration, in particular regarding to remuneration, social protection and integration within wider education systems. We would like to see the Alliance for Apprenticeships provide a simple mechanism for Apprenticeship policymakers and practitioners to exchange ideas and best practice."

**5. The social dimension of the Economic and Monetary Union (EMU)**

The Council held a policy debate, based on a Presidency note (doc. 14103/13 + COR1), on the social dimension of EMU. The main elements of this debate are contained in the Lithuanian Presidency letter to the President of the European Council.

The Council positively welcomed the Commission Communication on the social dimension of EMU and expressed support for the strengthening of the social dimension of EMU.

Delegations gave broad support to the creation of a social and employment scoreboard as part of the European Semester; work at the technical level is to continue. Although delegations expressed the necessity to consider the social implications of economic policies, there was no consensus on whether a limited number of auxiliary employment and social indicators should be added to the Alert Mechanism Report (of the MIP). On the issue of social dialogue, there was broad agreement of its importance at national and European level, and of its crucial role in the implementation of policy reforms. Delegations concurred that the current platforms can be used better and more intensively, as there is still scope for improving the synergy between the different *fora*.
