Having regard to Regulation (EU) No 492/2011 of the European Parliament and of the Council of 5 April 2011 on freedom of movement for workers within the Union¹, and in particular Articles 23 and 24 thereof.

Whereas:

- In its Decision of 25 September 2014², the Council appointed the members and alternate members of the Advisory Committee on Freedom of Movement for Workers for the period ending on 24 September 2016.
