1. The General Secretariat of the Council has been informed of the resignation of Mr Per EWALDSSON, as alternate member of the Governing Board of the above Agency in the government representatives category (for Sweden).
2. Under Article 8 of Regulation (EC) No 2062/94, as amended by Regulation (EC) No 1112/2005, members of the Governing Board are appointed by the Council.

3. In accordance with the usual procedure, the government of Sweden has nominated the following candidate for this seat for the remainder of the current term of office, ending on 7 November 2016:

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Council Regulation (EC) No 2062/94 of 18 July 1994 establishing a European Agency for Safety and Health at Work¹, and in particular Article 8 thereof,

Whereas:

- (1) In its Decisions of 2 December 2013², of 12 June 2014^{3,4}, of 18 November 2014⁵, of 15 December 2014⁶, and of 16 March 2015⁷ the Council appointed the members and alternate members of the Governing Board of the European Agency for Safety and Health at Work for the period ending on 7 November 2016.
- (2) A seat as alternate member in the government representatives category has fallen vacant as a result of the resignation of Mr Per EWALDSSON.
- (3) The government of Sweden has nominated a candidate for the vacant seat,
